### ORDER:-

In pursuance of the approval of the Governing Council in the reference fifth cited, the Tamil Nadu Dr. MGR Medical University grants Conditional Continuance of Provisional Affiliation for BNYS degree course for the academic year 2019 - 2020 to **Nandha Naturopathy and Yoga Medical College, Erode** run by Sri Nandha Educational Trust, Erode District subject to usual conditions already communicated in Provisional Affiliation order of this University.
