PREAMBLE :

In the reference first cited, the Government have permitted the Sri Nandha Educational Trust, Erode District for starting of new Naturopathy and Yoga College in the name of "Nandha Naturopathy and Yoga Medical College", at Erode District for the academic year 2018-2019 with an annual intake of 60 (sixty) seats.

2. In the reference second cited, the University had granted order of Provisional Affiliation to **Nandha Naturopathy and Yoga Medical College, Erode** for conducting **BNYS Degree Course** with an annual intake of 60 students for the academic year 2018 – 2019.

3. In the reference third cited, Grant of Conditional Continuance of Provisional Affiliation was issued for BNYS Degree Course with an annual intake of 60 seats for the academic year 2019 – 2020.

4. As the Building of the said institution is situated in the non-plan area, Sri Nandha Educational Trust, Erode has submitted a notarized affidavit duly signed by the Chairman for the academic year 2020-2021 with regards to DTCP approval procedures.

5. Due to Covid-19 Pandemic, the University inspection of the B.N.Y.S Degree Course with an annual intake of 60 seats could not be conducted. Based on the Resolution No.4 (4) passed at the 277th Governing Council meeting held on 30.09.2020, the Principal has submitted a notarized Affidavit of Undertaking of duly signed by the Chairman to abide by the appropriate rules regarding non conduct of regular inspection for the academic year 2020-2021.

ORDER:

Based on the approval of Governing Council held on 30.09.2020, the Tamil Nadu Dr. M.G.R. Medical University, Chennai grants Conditional Continuance of Provisional Affiliation to **Nandha Naturopathy and Yoga Medical College, Tiruvachi Panchayat, Pitchandampalayam Post, Erode – 638 052 run by Sri Nandha Educational Trust, Erode District**, for conducting BNYS Degree course for the academic year 2020-2021 for 60 seats, subject to usual conditions already communicated in Provisional Affiliation order of this University for the subject as indicated below:-
