ORDER:

The Government in G.O(Ms) No.175, Health and Family Welfare (IM1-2) Department, Chennai, dated: 10.05.2018 have granted permission to Sri Nandha Educational Trust, Erode District to start B.N.Y.S degree course in the name and style of Nandha Naturopathy and Yoga Medical College, Erode for the academic year 2018-2019 with an annual intake of 60 Seats

- In the reference second cited, the Chairman, Sri Nandha Educational Trust, Erode District has requested this University to issue Letter of Consent of Affiliation for starting B.N.Y.S degree course with an annual intake of 60 seats.
- In the reference third and fourth cited, Letter of Consent of Affiliation was issued to the Trust to make necessary arrangements to start B.N.Y.S degree course in their proposed Naturopathy Medical College.
- 4. In the reference fifth cited, the Trust, Sri Nandha Educational Trust, Erode District has applied for grant of Provisional Affiliation for starting B.N.Y.S degree course at Nandha Naturopathy and Yoga Medical College, Erode with an annual intake of 60 (Sixty) seats and it was processed by appointing an inspection team which conducted the inspection on 08.09.2018. The inspection team has also observed that the above college has fulfilled all the requirements for grant of Provisional Affiliation for starting B.N.Y.S degree course.

- 5. In pursuance of the Inspection report, this University is hereby grants Provisional Affiliation for the starting First Year B.N.Y.S degree course with an annual intake of 60 seats from the Academic year 2018-19 at Nandha Naturopathy and Yoga Medical College, Erode run by Sri Nandha Educational Trust, Erode District.
- 6. Any other conditions, which the University considers necessary to impose from time to time should be followed. This Provisional Affiliation is granted subject to the conditions given in the annexure also.

 - 8. The receipt of the Proceedings be acknowledged immediately.

ANNEXURE

The Provisional affiliation is granted subject to the following Condition.

- i) The admission procedure as laid down in Government Order should be followed.
- ii) The candidates should be admitted before the cut off date and they will be registered to take up their I Year Examination as per existing regulations.
- iii) There shall not be any admission after the cut off date.
- iv) The 2nd installment of Rs.3,00,000/- (Rupees Three Lakhs only) Security Deposit should be created for 2019 2020 and the 3rd installment of Rs.3,00,000/- (Rupees Three Lakhs Only) Security Deposit should be created for 2020 2021.
- v) The Trust should undertake to abide by the provisions of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987) and by the Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr.M.G.R. Medical University applicable to the Naturopathy and Yoga Colleges framed from time to time.
- vi) The Trust should agree for the inspection of the college by the Tamil Nadu Dr. M.G.R. University at any time according to the Statutes, Ordinances, Regulations and Rules for Naturopathy and Yoga College framed from time to time.
- vii) The Trust should abide by the Statutes, Ordinances, regulations and Rules framed by the Tamil Nadu Dr.M.G.R. Medical University on matters of Syllabus, Examinations, Code of conduct, extracurricular activities, etc. according to the Statutes, Ordinances Regulations and Rules of the Tamil Nadu Dr.M.G.R. Medical University framed from time to time.
- viii) The Conditions prescribed by the Central Council of Indian Medicine, New Delhi shall be followed. The Institution shall produce a copy of orders granting clearance/approval by Central Council of Indian Medicine, New Delhi to this University for records.
- ix) Only qualified staff shall be appointed to handle the classes. No unqualified staff shall be appointed.
- x) Only eligible candidates according to the regulations of this University shall be admitted to the 1st year B.N.Y.S Degree Course. While making admissions, the Rule of Reservation of the Government of Tamil Nadu shall be adopted strictly.
- xi) The sanctioned strength for the I year B.N.Y.S Degree Course should be within the sanction intake. It should not be exceeded. The admission of students should be made after the date of issue of this Proceedings.
- xii) There shall not be any financial commitment either to this University or to the Government.
- xiii) Hostel accommodation shall be made available for the students.
- xiv) Required furniture shall be provided wherever they are necessary.
- xv Furnishing of false information to the University on any matter of suppression of facts while furnishing information to the University or violation of any of the Statutes, Ordinances, regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the affiliation of the course.
- xvi The institution shall show evidence of an annual income of not less than Rs.50,00,000/- (Rupees Fifty lakhs only) excluding the interest accrued from the Security Deposit mentioned in the Statutes to facilitate the proper running of the proposed Naturopathy & Yoga College.
- xvii The said trust should create the prescribed endowment with Director of Medical Education, Chennai vide G.O.Ms.No.1190, Health and Family Welfare Department, dated 30.8.1991.
- xviii The College shall furnish a "Utilization Certificate" to the University stating that the interest accrued on the Security Deposit created with this University shall be utilized towards maintenance of the Naturopathy & Yoga Medical College.
- The trust shall have a duly constituted Governing body with a representative of the teaching staff, to advise the Principal in the affairs of the College. A record of proceedings of the said Governing Body of the College shall be maintained by the Principal.

- XX A nominee of the University shall be a member of the Governing Body to represent the interest of the University.
- xxi The Member nominated by the University under Statute 19 of the said Statutes shall hold office for a period of 3 years. Any change in the Governing Body of the College shall be reported to the University immediately.
- The Governing Body of the College shall meet at least once in every three months to consider the Budget Estimates and such other matters as may arise in its functioning. It shall meet in May-June each year to consider the Annual Report the audited statement of accounts, changes in affiliation or approval to be sought in the following year, etc. A copy of approved notice of meeting shall be sent to the nominee of this University, with a copy to the Registrar, at least 15 clear working days before the date of the meeting. A copy of the minutes of the meeting shall also be sent to the nominee and the Registrar of this University within 15 days from the date of the meeting.
- xxiii The College shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the second, third and fourth year of the course of study.
- xxiv The provisional affiliation now granted by the University is for the first year of B.N.Y.S degree course only.
- After fulfilling all the conditions, required to be fulfilled by the College under the Tamil Nadu Dr. M.G.R. Medical University (Affiliation of Naturopathy and Yoga Medical College) Statutes, by the end of the I year B.N.Y.S degree course of study, the institution shall apply to this University for the grant Continuance of provisional affiliation for the Second year B.N.Y.S degree course of study.
- xxvi During the University Examination, the Question Papers will be sent through Internet for which the following equipments have to be purchased and kept ready by the Institutions.
